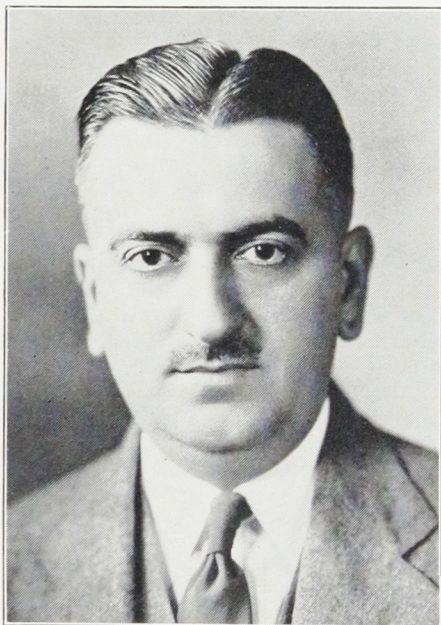
THE GRAND REGENT

PROFESSOR FLORIN J. AMRHEIN

Assistant Professor of Chemistry, Massachusetts
College of Pharmacy

Professor Florin J. Amrhein was born in Boston, Massachusetts, on August 3, 1892, the son of John and Catherine Amrhein. He attended the Dudley Elementary School in the Highlands section of Boston and received his secondary education in the Boston Public Latin School. He received his professional education and training at the Massachusetts College of Pharmacy and Boston University in which institutions he secured the degrees of Ph.G., Ph.C., and B.S.

At the age of thirteen he became apprenticed to Cyrus Davies, one of the old school pharmacists of the Highlands section and later he was for five years in the employ of E. G. Bossom whose store supplied the wants of many prominent Bostonians of the Back Bay section. Professor Amrhein was initiated as

a member of Mu Chapter on January 10, 1913, almost twenty years ago and during all these years he has been an active Kappa Psi worker.

In 1915 he was appointed assistant in the Pharmacy Department of the Massachusetts College of Pharmacy and in 1916 he was transferred to

the Chemistry Department in a similar position. In 1917 he was appointed Instructor in Analytical and Organic Chemistry and in 1921 he was appointed Assistant Professor of Chemistry which position he now holds. At the time of his graduation from the Massachusetts College of Pharmacy he received the A.Ph.A. certificate for Excellence in Pharmacy.

During the years 1918 to 1920 he held a lectureship in Chemistry and Urine Analysis in the Training School for Nurses at the Long Island Hospital, Boston Harbor.

On November 24, 1920, Professor Amrhein married Elizabeth McCarty, M.D., graduate of the Boston University Medical School, member of Lambda Kappa Sigma Sorority, and at the time Bacteriologist at the Long Island Hospital. Professor and Dr. Amrhein have one child, Florin, Jr.

Professor Amrhein has been chairman of the New England Branch of the A.Ph.A., and for fourteen years he has been Secretary of the Alumni Association of the Massachusetts College of Pharmacy. About ten years ago he was elected permanent treasurer of Mu Chapter and in 1921 as a result of his efforts Mu Chapter established a Kappa Psi Scholarship Fund from which a scholarship has been paid each year since to the senior student with the highest scholastic standing in the chapter. At one time Professor Amrhein was chemist in charge of the Division of Food and Drug Inspection for the Health Department of the Town of Brookline, Mass. He is a member of the American Pharmaceutical Association, Massachusetts State Pharmaceutical Association, Honorary Member of the Vermont Pharmaceutical Association, Boston Association of Retail Druggists, Boston Druggists Association, American Chemical Society, American Public Health Association, New England Chemistry Teachers' Association, Fellow of the American Institute of Chemists, Auxiliary member of U. S. P. Sub-committee No. 7, A.O.A.C., The Chemists' Club of New York City, and Brookline Lodge of Elks. Professor Amrhein is the author of a Textbook in the Examination of Urine and also of a laboratory manual in Food and Water Analysis. He has contributed to the scientific literature of pharmacy, and at the Toronto meeting of the A.Ph.A., he presented a paper "A Comparative Study of the Commercial Varieties of Mild Silver Protein." For several years he has been conducting research on the Chemistry of the Viburnums. At the recent National Convention of the N.A.R.D., held in Boston he was one of the convention speakers.

THE FIRST GRAND VICE-REGENT

PROFESSOR A. O. MICKELSEN

Dean and Professor of Pharmacy, Bacteriology and Physiological Chemistry, North Pacific College of Oregon

Dean A. O. Mickelsen has been associated with Kappa Psi for a period of twelve years. During that time, he has proven his worth in the advancement of Kappa Psi and of Pharmacy. After six years of service first as instructor and then as professor of pharmacy at the North Pacific College of Oregon, School of Pharmacy, Professor Mickelsen was appointed Dean of Pharmacy. For two years he served as Satrap of the Northwestern Province during which time two province conventions were held with a full delegate representation from all five chapters of the province. He was instrumental in installing chapter Pi of Rho Chi National Honorary Pharmaceutical Society at the North Pacific College. At present, he is sponsoring dental pharmacy in the Pacific Northwest. In the interest of professional pharmacy, he has obtained a sufficient number of members of the American Pharmaceutical Association to start a branch of the A.Ph.A. at Portland. When the American Medical Association held its convention in Portland, 1928, Dean Mickelsen was chosen as Chairman of the U.S.P. Convention Exhibit. The exhibit won the National Certificate as being the best educational display at the convention. Dean Mickelsen was one of five members to compile the Pacific Drug Review Prescription Schedule which has been accepted as a contribution to pharmacy.

Before the World War, A. O. Mickelsen had specialized in commerce and in public accounting, but due to an injury sustained during his fifteen months of service, he was forced to develop another professional line and he chose pharmacy. His training includes a college course in law. He is a member of the American Legion, Post No. 1, Portland, Oregon. Through his sound judgment and sincerity of purpose he has become a leader in his profession. To know him is to admire him; he has a most pleasing personality. His enthusiastic efforts are directed only toward advancement in those things he undertakes.

THE SECOND GRAND VICE-REGENT

PROFESSOR CLYDE MASON SNOW

Professor of Pharmacy, University of Illinois
School of Pharmacy

Clyde Mason Snow was born at Earlville, Illinois, on March 9, 1868. He received his early education in the grade school and high school of Earlville, and then entered the Maryland Military and Naval Academy. Following his graduation from the Academy, he took a business course in the Bryant and Stratton Business College. Later, he graduated from the University of Illinois School of Pharmacy, and did graduate work in the University of Chicago and received the Master of Arts degree.

His teaching positions have been as follows: Assistant in Pharmacy, University of Illinois School of Pharmacy; Associate Professor of Pharmacy, and later Professor of Pharmacy in the same institution; Instructor in Pharmacology, Materia Medica and Therapeutics, College of Medicine, University of Illinois; Lecturer on Pharmacy, Loyola University, Chicago College of Medicine and Surgery. He is a member of the American Pharmaceutical Association, the Illinois Pharmaceutical Association, A. F. & A. M. of Earlville, Delta Kappa Sigma Fraternity.

Professor Snow was president of the Class of 1902 of the University of Illinois School of Pharmacy. He is an auxiliary member of the Revision Committee of the U.S.P. X, and a member of the Committee on Revision National Formulary IV and V. He is the author of two well known textbooks, viz., "Essentials of Pharmacy" and "The Arithmetic of Pharmacy."

GEORGE HARRISON FRATES

Executive Committee, Northern California Retail
Druggists Association

George Harrison Frates was born in 1891 in Ione, Amador County, California, a section of California made famous during the Gold Rush days of '49. His parents later moved to San Francisco, the youthful George attending Polytechnic High School and graduating from that institution in 1910. Executive honors came early to George Frates, his schoolmates having elected him President of the Student Body in 1909-1910. During these years Mr. Frates' ability as a leader and executive grew steadily and became recognized by his fellow pharmacists, and, after serving as President of the San Francisco Retail Druggists Association

in 1929, he was elected to the Presidency of the California Pharmaceutical Association for the year 1929-1930. 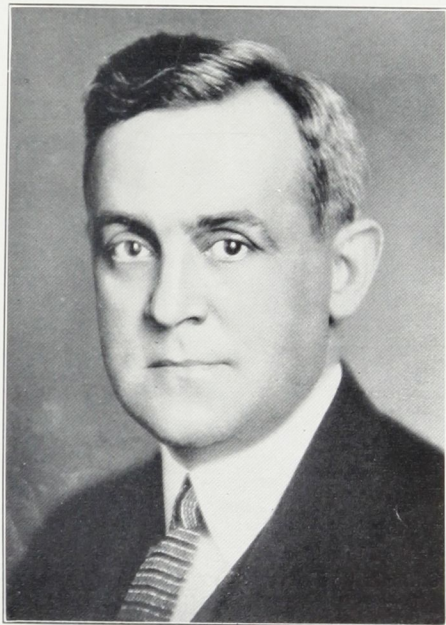
Mr. Frates' personal life has been graced by a charming wife and two children—a young daughter, and a son attending high school.

THE GRAND SECRETARY AND TREASURER

PROFESSOR ANDREW RICHARD BLISS, JR.

Dean and Professor of Pharmacology, University of Tennessee
School of Pharmacy

Professor Bliss was born in New York City on November 10, 1887, the son of Andrew Richard Bliss and Frances Revue (Sutton) Bliss. He was educated at Public School No. 15 and Dewitt Clinton High School, New York City, New York College of Pharmacy, New York University, Columbia University, Howard College of Birmingham, Alabama, and the University of Alabama. He received the following degrees: Ph.G., New York College of Pharmacy; Ph.Ch., Columbia University; Phar.D., Columbia University; B.S., Howard College; A.M., Howard College; and M.D., University of Alabama. In May, 1932, Howard College conferred the degree of LL.D. on him in recognition of his contributions to science and education. From 1906 to 1908 he acted as assistant to Dr. William Mansfield. In 1909 he accepted a call to the University of Alabama at Tuscaloosa as adjunct professor of chemistry and pharmacology, moving from there to the Birmingham divisions of the university in 1909 to accept the professorship of chemistry and pharmacology; and in 1910 he became also dean of the College of Pharmacy. In 1915 he was called to Emory University at Atlanta, Georgia, as professor of pharmacology, and in 1923 accepted the position of chief of the Division of Pharmacology and Physiology in the University of Tennessee at Memphis. In 1925, he was selected also as dean of the School of Pharmacy.

Professor Bliss has contributed over sixty articles to scientific and edu-

cational literature, and is the author of four textbooks. He has gained not only a wide reputation as an author, a research worker, and an educator, but also as an organizer of scientific departments and a builder of laboratory buildings.

Professor Bliss was chosen to conduct the pharmacological and physiological studies for the Educational Research Committee of the Commonwealth Fund—*A Study of Pharmacy from a Functional Standpoint* (McGraw-Hill Book Co., 1927). He assisted with the work of the Tenth Revision of the *U.S.P.* as an auxiliary member, and with the revision of the *N.F., V.*, and in May, 1930, was elected a member of the *U.S.P.* Revision Committee. During the World War he was a lieutenant in the Medical Department of the U. S. Army, 1918-19, and, following his discharge from the Army, he was commissioned a Passed Assistant Surgeon (Associate Pharmacologist) in the U. S. Public Health Service Reserve. In April, 1932, he was selected to act as Director of the Reelfoot Lake Biological Station, established by the State of Tennessee and placed under the direction and control of Tennessee Academy of Science of which Dr. Bliss is president.

He is a member also of Kappa Alpha, the American Legion, Memphis Chamber of Commerce, Knights Templar, 32nd Degree Scottish Rite, Shrine, Square and Compass Fraternity, Theta Kappa Psi Medical Fraternity, etc. He is a fellow of the American Association for the Advancement of Science, the American Institute of Chemists, the American Academy of Political and Social Science, and the American Geographical Society of New York. He is also a member of the American Chemical Society, the American Pharmaceutical Association, the Tennessee Academy of Science, the Association of Official Agricultural Chemists, the Biochemical Association, Science League of America, American Association for Medical Progress, Annual Conference of Biochemists, Medical Association of Georgia, World Conference on Narcotic Education, International Narcotic Education Association, Asklepios Honor Medical Fraternity, Sigma Tau Delta Professional English Fraternity, Pi Gamma Mu Social Science Honor Society, and Iota Sigma Honor Fraternity. He is a member of the Episcopal Church, president of the Churchmen's Club, and a member of the Chapter of the Episcopal Cathedral of Memphis.

Doctor Bliss married Miss Loretta Ann Deering, daughter of John Deering, an engineer of New York City.

His name appears in *American Men of Science*, *Who's Who Among North American Authors*, *Who's Who in American Medicine*, *The Naturalist's Directory*, *The National Cyclopedia of American Biography*, and *Leaders in Education*.

THE GRAND HISTORIAN

PROFESSOR LEASURE KLINE DARBAKER

Professor of Pharmacognosy and Bacteriology, University of Pittsburgh, College of Pharmacy

Leasure Kline Darbaker, son of Henry David and Agnes Jane (Kline) Darbaker, was born in Pittsburgh, Pa., on January 13, 1879. He was educated in the public schools of McKeesport and Emlenton, Pa., and later attended Grove City College, Ohio Northern University, University of Berlin, Germany; University of Pittsburgh. He received degree Ph.G. from the Ohio Northern University in 1900 and the same degree at University of Pittsburgh in 1906, and Phar.D. at University of Pittsburgh in 1909. He began his apprenticeship with H. R. Gilmore, Emlenton, Pa., in 1900. Later he did Blood Work with Wright, of London (England), and later Bacteriology with Lederman, Klopstock, and Kwarsky in Berlin, Germany.

He is Consultant in Bacteriology and Microscopy at the Pittsburgh Microscopical Laboratory and also American Bureau Inspection and Tests, Pittsburgh, Pa. From 1907 to 1909 Dr. Darbaker served as Assistant in Pharmacognosy at the

University of Pittsburgh College of Pharmacy; from 1908 to 1914 he served as Assistant in Pharmacognosy, Materia Medica and Botany, at Pittsburgh College of Pharmacy. In 1910 he originated the course in Microbiology, Histological Pharmacognosy and Microscopy at the University of Pittsburgh College of Pharmacy and assumed the post of Professor in these subjects, which position he holds at the present date. In 1931 he originated the course in Biology at the same institution and was chosen as Professor in this subject.

On August 9, 1915, Dr. Darbaker married Susan B. King, of Emlenton, Pa. Dr. Darbaker joined the Pennsylvania Pharmaceutical Association in 1909 and was elected to Life Membership in 1925. He has attended the annual meetings regularly since his affiliation and has served on many committees.

Dr. Darbaker holds membership in many social, scientific and fraternal organizations, a few of which are listed here: Faculty of the University of Pittsburgh College of Pharmacy; American Pharmaceutical Association; Pittsburgh Branch, American Pharmaceutical Association; American Association Advancement of Science; American Chemical Society; American Society of Bacteriologists; American Society of Plant Pathologists "Botanical"; American Plant of Physiologists; Western Pennsylvania Botanical Society; Pittsburgh Academy of Art; American Microscopical Society; Society of Pennsylvania Pharmacognocists; American Malcological Union; A.F.A.M.; Phi Sigma; and Collembola.

Dr. Darbaker has written many articles relating to Hematology, Urinology, Bacteriology, and Pharmacognosy. He is the author of Manuals on Microscopy; Histological Pharmacognosy; Microbiology, and Biology.

THE GRAND RITUALIST

PROFESSOR FERDINAND D. STOLL

Professor of Pharmacy, Louisville College of Pharmacy

Ferdinand D. Stoll was born in Winterthur, Switzerland, July 29, 1899. Two years later his parents came to America and settled in Louisville, Kentucky. There he attended local schools and in 1914, when his father died, took a position as apprentice in the store of George Zubrod & Company, one of Louisville's oldest real pharmacies—a store which dealt in crude drugs, chemicals, oils, where they made practically all their own preparations—and under the guidance of his preceptor, began to acquire a real foundation and education in pharmacy. One of his preceptors, Mr. Wm. G. Zubrod, was a former instructor at the L.C.P., and under his guidance and that of his father and brother, Brother Stoll's practical and theoretical training was most valuable.

In 1915, after passing entrance examinations, he matriculated in the Louisville College of Pharmacy and completed the first year with second honors. He did not return to college the next session, but completed the course in 1917-18, graduating with highest honors.

In 1919 he was appointed assistant in chemistry at the L.C.P. and in the same year gained much practical experience in the prescription department of the Newman Drug Company.

In 1920 he accepted the post of professor of botany and histology at the L.C.P. and as this did not demand all his time, he served as head pharmacist for the T. P. Taylor chain in Louisville.

Upon the death in January, 1925, of Dr. O. C. Dilly, dean and professor of pharmacy of the L.C.P., Brother Stoll was appointed professor of theoretical and practical pharmacy in which capacity he is still engaged. During the summer months he has been in the service of the T. P. Taylor Company as prescriptionist.

In addition to Brother Stoll's duties at the L.C.P., he has also, for the past six years, taught regularly classes of nurses from the Louisville hospitals.

During the past five years he has contributed popular and educational papers to the *American Druggist*, *Druggists' Circular*, *THE MASK*, and is a regular contributor to the *Journal of the Kentucky Pharmaceutical Association*. Also he presented a paper at the Maine convention of A.Ph.A.

Brother Stoll holds membership in the Kentucky Pharmaceutical As-

sociation, the A.Ph.A., and Kappa Psi Fraternity. He has been actively identified with the latter since 1919. In 1920 he was made secretary of the Upsilon Chapter and in 1928 was appointed Grand Ritualist. He is also member of Willis Stuart Lodge F.&A.M. and of F. H. Johnson Lodge R.A.M. and a member of the Fourth Avenue, Presbyterian Church where in 1929, he was married to Miss Clara Parker, R.N., of Cleveland, Ohio.

At the present time he is actively engaged in instructing at L.C.P. and hospital classes, in fraternity work, and is completing the university work leading to a Master of Science this summer.

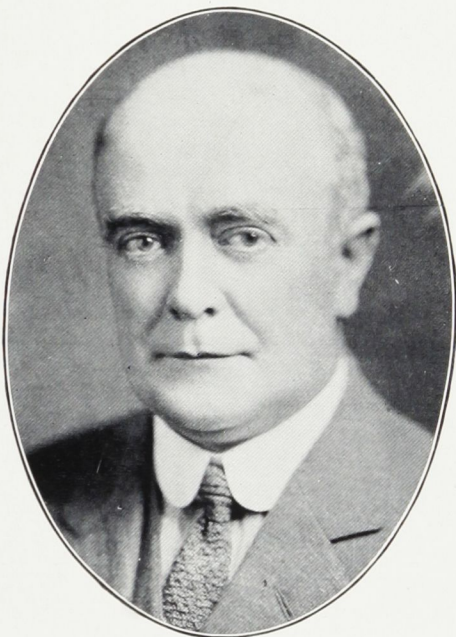
THE GRAND COUNSELOR

DR. W. BRUCE PHILIP

President, American Pharmaceutical Association; Lecturer on
Pharmaceutical Jurisprudence, George Washington
University College of Pharmacy

W. Bruce Philip was born in Sacramento, California, on July 19, 1878. He attended the grammar and the high school at that city, graduating from the latter in 1896, when he was 18 years old. In 1899 he entered the College of Pharmacy of the University of California, and graduated in 1901 with the degree of Ph.G. At the age of 23 he was a registered pharmacist and had a substantial interest in a fine growing business in San Francisco. De-

siring to make greater advancements, he entered the College of Pharmacy of Columbia University in 1903 as a candidate for the graduate degree of Phar.D., which was conferred upon him at the completion of the course. It was at Columbia that Bruce was initiated into Kappa Psi. He returned to San Francisco, and on November 24, 1904, married Miss Fayette Harris, a classmate while a student in the University of California. In February, 1905 they opened their own drug store in Fruitvale, California, where they contin-

ued in the practice of pharmacy until 1920. During this period they opened two branch stores, the firm name being "Philip & Philip."

In 1920 he became Secretary of the Alameda County Pharmaceutical Association, opening offices in the Balboa Building in San Francisco, and later became also Secretary of the San Francisco Retail Druggists Association. It was in 1920 also that he entered the University of Cali-

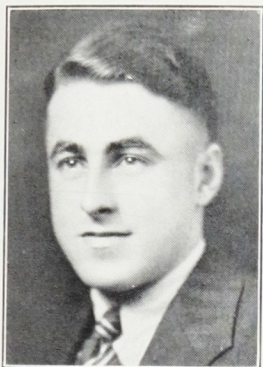
fornia Hastings College of Law, and in 1923 he graduated with the degree of LL.B., and was admitted to the bar soon thereafter. He built up a large law practice, specializing in cases involving pharmacists.

XI; President of the Conference of American Pharmaceutical Secretaries; Past-President of the San Francisco Secretaries Club; Past President of the Sacramento Retail Drug Clerks Association; member of the Athens Club, Orinda Country Club, A. F. & A. M., Knights of Pythias, Eagles, and Native Sons; also a member of the American Association for the Advancement of Science and the American Chemical Society; and a Trustee of the U.S.P. XI.

In 1929 the Philadelphia College of Pharmacy conferred the honorary degree of Ph.M. He is a member of the California State Bar Association, and the Phi Alpha Delta Law Fraternity. He served as Grand Historian of the Kappa Psi Fraternity, and in 1926 was elected Grand Regent, an office he held until the fall of 1932 when he became Grand Counselor of Kappa Psi.

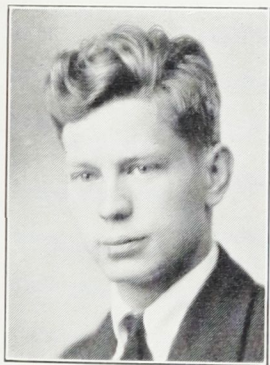

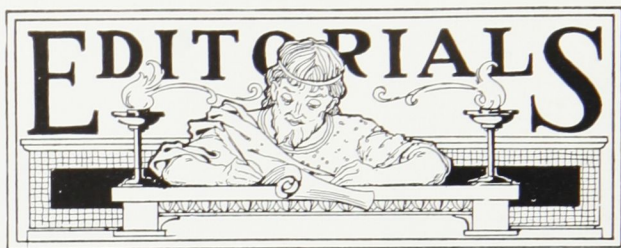
